



INTERLOCAL AGREEMENT BETWEEN THE COUNTY OF WAGONER, OKLAHOMA
AND THE CITY OF COWETA, OKLAHOMA CONCERNING COUNTY ROAD AND
DRAINAGE MAINTENANCE AND REPAIR

This agreement is made pursuant to the Interlocal Cooperative Act (74 O.S. § 1001, et seq.) by and between Wagoner County, Oklahoma (hereafter "the County"), and the City of Coweta, Oklahoma (hereafter "the City"). The express purpose of this agreement is to enable cooperation and to combine existing resources between the County and the City for continuing maintenance and repairs of South 353rd East Avenue between State Highway 51 and 151st Street, which is located partially within the City limits.

DURATION

1. This agreement shall be in effect from the date of its approval by both parties through project completion. This agreement shall expire automatically on March 31, 2021, unless the County and the City specifically renew this agreement beforehand.
2. Either party may request a modification of the agreement by making a written request identifying the desired amendments, or the subject matter thereof, at least forty-five (45) days in advance of any negotiation concerning amendment.
3. Either party may terminate this agreement by providing written notice to the other at least ninety (90) days prior to the proposed termination.

PURPOSE

The parties hereto, through each respective governing body, hereby find and declare:

1. WHEREAS, the above named parties need mutual assistance from each other in order to provide maintenance and repairs of South 353rd East Avenue between State Highway 51 and 151st Street.
2. WHEREAS, Title 69, Section 601 of the Authority and Duties of County Commissioners provides the mechanism for Counties to enter into agreements with other political subdivisions to perform any governmental service or activity. And
3. WHEREAS the aforementioned road falls within both jurisdictions', and
4. WHEREAS, the majority of the aforementioned road falls within the County's jurisdiction, the County has committed to providing improvements which crosses the City limit boundary in an effort to provide consistency to the citizens of Wagoner County as a whole.



POWERS AND DUTIES

The County shall act as the lead agency and will provide the oversight, labor and materials for the improvement of South 353rd East Avenue between State Highway 51 and 151st Street. The City shall provide financial support to the County for road materials in the amount of Forty Thousand Dollars (\$40,000.00).

MAINTENANCE AND OPERATION

The County and the City shall each retain ownership and long term maintenance responsibility for their respective portions of South 353rd East Avenue between State Highway 51 and 151st Street after the completion of this County road improvement project. The County agrees to cooperate and coordinate with the City to address any concerns that may arise during the duration of this agreement.

ADMINISTRATION

All parties expressly agree that each individual party to the AGREEMENT shall comply with the rules and regulations of the State of Oklahoma for the implementation of any project.
