- \*Application must be submitted to City Hall 10 days before the display.
- \*Attached application must be completely filled out.
- \*Copy of General Liability Insurance in the amount of \$1,000,000.00 must be Submitted.
- \*A copy of the State License of the operator must be submitted
- \* A plot plan of the display area
- \* No Display will be permitted within 500 feet of fireworks stand or storage.
- \* Inspection and approval will be made by the Fire Department

CONFORM TO THE REQUIREMENTS AS SET FORTH ON PERMIT. The permit, if issued, must be posted at the display site and surrendered upon request to the representative of the Coweta Fire Department. I further understand that no one is permitted to discharge any type or form of common fireworks at the site. The permit will not be transferable to another operator. Violation of these requirements may cause my permit privileges to be forfeited and future permits to be denied.
